1. Separation of Responsibilities

Responsibilities of Nulab Inc. ("us", "we" or "Nulab")

We will implement the following security measures.



- Security measures for the services provided by us (Backlog, Cacoo, Typetalk, Nulab Apps Management Screen (*1), Nulab Pass)
- Protection of user data stored in the above services
- Middleware, OS and other infrastructural security that is required for the provision of the above services

Nulab Apps Management Screen is the shared account ("Nulab Account") etc. functionality provided by Nulab.

Responsibilities of the user

The user shall be responsible for implementing the following security measures.

- Proper management of password (Including the management of devices used for two factor authentication)
- Proper Account (*2) management (Grant of authorities for registration, deletion, administration etc)
- Proper management of registered contents

Hereinafter, account might be referred to as user, however that should be all a reference to the account.



2. Location of Data Storage

All data received by our customers is stored in the data centers of the cloud vendors outlined below.

3. Deletion

If the Administrator follows the steps set forth by Nulab to terminate the use of the services ("Service Termination Request"*1), we will delete the data received by the users ("User Data"). Also, if a trial period ends without a submission of a request for a Paid plan, or if the Services are terminated for reasons such as delayed payments, the User Data will be deleted. In this case, upon completion of the deletion, the User Data cannot be retrieved even by Nulab. Conditions for deletion, timing of deletion and the User Data subject to deletion are set forth in the table below.

"Service Termination Request" means the below action.

• "Delete organization" in Nulab Account

X Notwithstanding the above, User Data will remain stored in the backup data collected for each service for a certain period even after the deletion completion dates listed above. For example, if the data's backups are made once a day and retained 30 times, the data will remain stored for 30 days in the data's backups after deletion is complete and will be deleted on the 31st day.

User Data Exempted from Deletion

All User Data registered by Users for each Service shall be deleted except for the following data:

- Data related to contracts, billing and deposit for each service
- Administrator's name and contact for each service
- Backlog space owner's name and contact (Classic Plan)
- Backlog space ID
- Nulab Pass' Nulab Organization ID
- Image inserts uploaded to Cacoo

However, in case of the deletion of the Nulab account, Managed Account or Backlog account(Classic Plan), the User Data in Backlog, Typetalk or Cacoo (excluding Free Plan and Plus Plan prior to November 27, 2019), created through the respective accounts, will not be deleted.

In order for these User Data to be deleted, it must fall into one of the items listed above other than "Nulab Account" or "Managed Account".

5. Adding and Deleting Users

For All Services (Excluding Backlog Classic)

User Registration

Customers can create a Nulab account through sign up (*1) or when they are invited to an organization. Accounts created through sign up will be administrators and they can perform the following organization management functions, such as "Invite to an organization" etc.

- Create a Nulab Account (Manual)
- Sign up for a Free trial of Backlog (Choose Plan)
- Sign up for a Free trial of Cacoo (Choose Plan)
- Sign up for a Free trial of Typetalk (Choose Plan)
- Sign up for a Free trial of Nulab Pass (<u>Trial Page</u>)

*1

Sign up refers to the use the Services through a free trial, or to the creation of a Nulab Account from the Sig Up option.



Delete Users

Users can always opt to delete their Nulab Account.

Only the users themselves can delete their Nulab Account.

• Delete Nulab Account (Manual)

Invite to an Organization

Users with the authority to invite others can always invite other users to their organization.

• Invite Users (<u>Manual</u>)

Remove from an Organization

Administrators can remove users from their organizations. By removing a user, such removed user will be unable to use the services used by the organization.

Backlog (Classic Plan)

Backlog (Classic Plan), can be used with a Nulab Account or by creating a Backlog-only user. Authorized users, within the scope of their contract plan, can add or remove users.

• Add, Manage, Delete Users (Manual)

Nulab Pass

Through Nulab Pass, customers can create Managed accounts that are using an IdP (Identity Provider) and can be used with Single-Sign On (SSO).

The administrator can register or remove managed accounts.

Based on the selected plan, audit logs can be recorded and saved.

- Create, Manage, Delete Managed Accounts (Manual)
- Set SAML Authentication (SSO) (Manual)
- Changing an account type (Manual)
- Audit log settings and file (Manual)

6. Access Rights Management

For All Services (Except Backlog Classic)

Users can set the access rights of a Nulab Account or a Team within an organization.



There are 3 types of authorities: administrator, general user and guest.

Also, general users can have the additional authorization to invite members.

- Add Invitation Authority to General Users (Manual)

Backlog

Users can set access rights to projects and the information within the projects.

Backlog (Classic Plan)

Backlog (Classic Plan) has an account and team management function.

Users can set authorities for the folders within an organization.

There are 3 types of authorities, "Viewer", "Editor" and "Owner".

The administrator of an organization can authorize certain members of the organization to use Cacoo.

Typetalk

Depending on the organization authorities set by the user, different authorities can be set for the topics within Typetalk.

7. How to Set Password

Nulab Account

Initial Password

Users can set their own password when they create their Nulab Account.

How to Change Password

• Password Management (Manual)

Backlog (Classic Plan)

For Backlog (Classic Plan), a password is automatically issued when the space administrator creates a new user.

Initial Password

When the administrator creates a new account, the initial password is generated and sent to the email address of the new account.

How to Change Password

• Change Password(<u>Manual</u>)

Nulab Pass

The login ID and the password to a Nulab Pass managed account is the login ID and the password set by the Customer on their IdP (Identity Provider).

Password information is not stored in Nulab Pass.

8. Encryption

User Information

- Each user information (such as name, email address) stored in databases are not encrypted but access rights are appropriately limited.
- Passwords are stored in an irreversible encrypted (hashed) state.

Correspondence with the Services

 Correspondence between Customer's terminal and the services provided by us are encrypted by SSL.

Database Encryption

• Database file are encrypted for the following services. Target service: Cacoo, Typetalk

11. Backup

For all Nulab Services

- Nulab is using the Snapshot function provided by AWS for the backup.
- Backup data is stored in high-availability and high-durability storage in AWS.
- The backup data is for the purpose of restoring the entire service, individual customer data cannot be restored individually.
- The region for the backup data is the same as the region specified in "2. Location of Data Storage".

Nulab Apps Management Screen / Nulab Pass

- The scope, frequency and retention period of backups performed by Nulab are as follows.
 - o Database (users, group etc): Saved once a day and retain 14 savings
- The above is described in our <u>Supplemental Terms regarding Security</u> as well.

Backlog

- The scope, frequency and retention period of backups performed by Nulab are as follows.
 - o Database (issues, wiki etc.): Saved once a day and retain 30 savings.
 - Shared files, Git, Subversion: Saved twice a day and retain 60 savings.
- The above content is also described in our Recovery actions during server outage as well.

Cacoo

- The scope, frequency and retention period of backups performed by Nulab are as follows.
 - O Database (figures, templates saved by user etc): Saved once a day and retain 14 savings...
 - Picture files used for figures: Since they are stored in highly available and highly durable storage, it is considered that there is almost no risk of loss, so they are excluded from backup.
- The above content is described in our <u>Security, privacy and outage policies</u>.

Typetalk

• The scope, frequency and retention period of backups performed by Nulab are as follows.



- o Database (topics, messages, etc): Saved once a day and retain 14 savings.
- Attached files: Since they are stored in highly available and highly durable storage, it is considered that there is almost no risk of loss, so they are excluded from backup.
- The above content is described in our Security, privacy and outage policies as well.

12. Time zone information for logs

- Logs within the services provided by Nulab are taken in GMT(UTC+0) or JST(UTC+9), which is the server time.
- Log times are synchronized with the NTP service provided by AWS.

13. Information for Vulnerability Management

- The services we provide are periodically assessed for vulnerabilities by a third party once a year. We examine the contents of any identified issues and take necessary actions.
- The development team of our services regularly collects vulnerability information related to the OS, middleware, etc. used for the provision of the services.
- If a vulnerability patch for a component used in our services is released, we will promptly apply it after verification in our test environment.

14. Secure Development Life Cycle

- Through carrying out code reviews, etc., we check whether basic vulnerabilities have been addressed.
- We check the libraries installed on the server for outdated versions, vulnerabilities, etc.



15. Incident Response

- In the event a security incident (as defined by us) occurs, we will contact the user's administrator by e-mail or by one or more other means based on our choice.
- Details of the above content are described in our Supplementary Terms regarding Security.

16. Protection and Third Party Provision of User Data

- It is our responsibility to protect the data entrusted to us by the users.
- User data, including log data, is stored under access rights that are set so that only a limited number of people in each service development team can access it, in order to prevent unauthorized access and falsification.
- However, if we are legally obligated to provide user data, in a legally recognized form, such as by
 an order from a competent court to submit as evidence, Nulab will provide such user data without
 the user's permission, to the minimum extent necessary.

17. Governing Law

• The agreement between us and the users is governed by the laws of Japan.



18. Authentication
